Annapolis Friends Monthly Meeting (AFM) Meeting for Worship with Attention to Business (MfB) Fifth Month, Fifth Day, 2024 (5/5/24)

<u>Present</u> were: Karen C. (clerk), Phil C. (recording clerk), Martha B., Margaret H., Nan & Sky E., Jack L., Ann R., Larry M., Margaret & Will C., Mary B., Phyllis S., Martha L., Jeanne W., Marjorie W., Ellen M., Cairn K., Dan C., Kathy T., Pat S., Ted R., Jean C., Ria H., Stephen P., and Diane S. with video staffing by Ben.

We met both in person and via Zoom, beginning with centering worship and screen-sharing of Baltimore Yearly Meeting's Fifth Month Faith and Practice queries. From the initial silence, our Clerk welcomed Friends and reviewed AFM's anti-racist queries, encouraging Friends with our brief agenda again to take time to consider the spirit that runs through our business concerns. We proceeded with reports and action items from various AFM committees.

Reflecting on our just completed spring **Quaker Market**, Friends commented that it was a great joy to see many children enjoying face painting, enormous bubbles and being chased by their grandmothers. Despite the rain, it was a wonderful time. Cairn thanked Friends who pitched in so many different ways, noting that Market is an opportunity for our community outreach and to let them know about Quakers. We also appreciate the opportunity to support the efforts of Orphan Grain train, Food Security Network, and other groups in their international and their community work. Another Friend from MHL thanked Friends who performed the miracle of returning the Meeting House to its normal state the morning after.

For Peace and Social Concerns Committee (PSC), Margaret H. reported a decision to be made about <u>replacing our old Black Lives Matter banner</u> which has become weather-beaten and ragged. The Committee has discussed options and recommends a replacement with a new banner closer in size to our RRC Community Conversations banner. Friends approved.

Another Friend recommended a <u>rainbow banner</u> be considered also to show support for the LGBTQ community. The Committee will consider this and bring back a recommendation.

Announcement — As AFM traditionally has supported <u>Md. Peace Action's Peace Writing</u> <u>Contest</u> for middle school students, PSC has requested a \$250 contribution from the Committee Contingency fund to reimburse $\frac{1}{3}$ of mailing costs.

Announcement- AFM, in the past, has supported <u>postcarding efforts for voter turnout</u> with the Center for Common Ground, a nonpartisan organization, so this would not conflict with our 501c3 status. Friends supported this idea with many raising our hands to show an intention to participate. The Committee will make further announcements soon and will offer dates and arrangements to do this.

Responding to concerns expressed by Friends in prior Meetings, PSC hopes to <u>reopen</u> <u>conversation about AFM's fundraising policy with a general Listening Session in September</u>. This likely will be the first of several meetings becoming more focused on our highest priorities going forward. We hope this also will fit in with another upcoming priorities discussion of Meetinghouse and Lands (MHL) meeting on 5/9.

For Meetinghouse and Land Committee (MHL), Jeanne W. reminded Friends of a <u>meeting for listening on 5/9, from 7 to 9 p.m., to discuss concerns in relation to the Building Fund</u> with a virtual option, Friends are asked to RSVP and encouraged to bring desserts. MHL hopes to offer "fact-based discernment" – to include historic information about the building fund, historic

plans for possible Meeting House expansion, and to solicit Friends' other concerns. Cost estimates will be offered but these are about 5 years old, so actual costs would be higher. The Committee will record the Meeting for Friends who are unable to attend.

Ellen M. also reported for MHL as to <u>efforts to connect with our neighbors</u>. Ellen & Barb T. attended the neighborhood's annual association meeting to discuss neighbor's concerns about occasional car speeding and a couple of exuberant renters' performance. With about 15 neighbors in attendance, the group discussed that local traffic authorities already have assisted in installing signs and trimming back shrubbery along the road, but speed bumps and traffic calming signs have been rejected due to the low traffic count. Ellen explained the past efforts of AFM to remind ourselves to be cautious because of children playing and the lack of sidewalks for pedestrians. Most of the 15 neighbors attending were supportive saying "we love you guys"; but some, who arrived during the pandemic, regard our return to renting normalcy to be a huge increase. We also alerted the neighbors as to Quaker Markets and some neighbors in fact came and enjoyed the day. The meeting concluded with "good vibes." One Friend suggested adding signs on AFM's own property outside the front door and near the driveway exit to urge those to "drive slowly." The Committee will discuss these recommendations. Friends thanked Ellen and Barb for this valiant effort.

For Stewardship and Finance Committee (S&F), Jack L. reported three announcements:

- 1) To open additional options for Friends to support Meeting financially, AFM will expand our current use for renters of Zelle fund transfers to make this available for AFM donors' use. Information and simple instructions on how to use the system will be posted on AFM announce and our annual letter to donors will explain how Zelle donations may work. Jack says that he has used Zelle and says that "it's safe and efficient." He noted that this will be separate from the AFM online "donate" button.
- 2) S&F committee also announced that the committee is considering a Donation button to the AFM website and invited Friends' questions and comments about possible use of this.
- 3) Jack also noted that our Treasurers' quarterly report was sent via Announce.

One Friend expressed concerns about <u>whether our MfB minutes should include Friends' last</u> <u>names.</u> One Friend recalled that the current system of last initials was adopted due to concerns for possible privacy violations if minutes were accessible online; another commented that, without more information, this might be unlikely for privacy violations. The concern was referred to Communications Committee for further discernment.

We returned again to consider a concern as to wording of a **past MfB minute** that recorded a Friend "standing in the way" as compared to one Friend's requested minute stating "*A Friend rose in the traditional Quaker manner and noted the spirit directed them to stand in the way of the proposal and reconsider. Meeting determined that the discernment was not valid for the proposal and chose to proceed accordingly.*"

Many Friends offered views which included:

-One not favoring the statement as stating that the "discernment was invalid"; but suggesting that we record this disagreement.

-Another Friend said the original minute's "language and formulation is inconsistent with traditional practice." She expressed the concern that the traditional practice would have the clerk determine the sense of the Meeting, but that this would not mean the Meeting was right or wrong.

So, the Meeting and the Friend in disagreement would not be opposed to each other. She noted that Friends don't always succeed in understanding where Spirit is leading us. We are all trying to be faithful and to follow where the spirit leads us."

-Another Friend noted their understanding that "stand in the way" means that the Meeting can't move forward. However, in this instance, the sense of the Meeting was to move forward. The Friend noted that the decision was about the upcoming Quaker Market while the concern was about the Building fund, our budgeting process, and fundraising issues, which are separate issues that we will return to later.

-Our clerk suggested that, in addition to the May MHL listening session and the September PSC listening session, S&F hold a listening session on the budget in the fall. Cairn, as clerk of QM committee, noted that early discernment–months in advance–is important for QMs.

-Another Friend suggested that the wording of the proposed corrected minute sounded "rude" and perhaps that the wording could have been softened to avoid saying Friends' discernment was "not valid."

- Yet another Friend agreed and suggested that we use the first suggested proposed sentence and add that *"Friends agreed more seasoning was needed, that there was not time currently to consider better phrasing of the minutes, and that Friends would return to these minutes and to the larger concerns raised in the future."*

-Our clerk suggested that the minute should include a statement that "our clerk determined the sense of the Meeting was to move forward given the time constraints," as well as using the term "sense of the meeting" and not the term "standing in the way." This would recognize, as discussed in recent BYM programs on clerking, that Friends cannot block the sense of the meeting, but they may be recorded as "standing aside." It is rare, but it can happen that Friends choose to proceed even though another Friend has expressed strong disagreement. We all need to listen openly to every Friend's concerns.

-Another Friend noted that the original view was shared by two Friends, pointed to two much larger concerns that some have experienced. She noted that the pending Listening Sessions may begin to address these bigger concerns.

Another Friend urged that we recognized that, as we age and participate remotely, many Friends may feel alienated and separated from the Meeting and thanked others to "search your hearts and be sure that you are remembering other Friends who may not be physically present."

Our Clerk thanked Friends for these discussions and suggested that we leave our March minutes as originally presented and direct readers of those minutes to the April minutes, which describe the proposed change, and these May minutes, which record various concerns and discernment. Friends approved this plan. Friends, including those online, agreed with the Clerk's suggestion and deferred final approval of these minutes in the interest of time.

We concluded with brief silence.
